BZSt employees may send unencrypted e-mails with protected data only if the data subject expressly consents to the unencrypted transfer of data and thus accepts the potential disclosure of their tax situation associated therewith via this method of communication (Section 30 Paragraph 4 (3) and second half of sentence 3 Section 87a Paragraph 1 AO, Article 6 (1) General Data Protection Regulation [GDPR]).

If BZSt may send unencrypted e-mails to you or to the person you have authorized, please personally sign the template completed in full and mail it to BZSt.

Please make sure that your personal signature is visible in the attachment.

This consent does not imply any entitlement to unencrypted e-mail communication. BZSt thus reserves the right to select another method of communication (e.g. by mail), for instance if e-mail communication is not possible for technical reasons or if transmission via another method is required. In particular, notices of assessment are not permitted to be announced by unencrypted e-mail.
